本製品の概要

この章では、本製品の概要について説明します。

特徴

本製品は、JP1/Network Node Manager i が HA8000V シリーズ/RV3000(以降、管理対 象)の SNMP トラップを受信したときのアクションとして呼び出され、管理対象の SNMP トラップを JP1 イベントに変換して送信するアプリケーションです。管理対 象の SNMP トラップを、独自の変換ルールと管理対象の SNMP トラップの MIB 定義 ファイル相当の情報を使用して JP1 イベントに変換します。

JP1 イベント通知ツールのインス トールとセットアップ

この章では、JP1 イベント通知ツールのインストールとセットアップ 方法について説明します。

前提環境の準備

以下の手順で、JP1イベント通知ツールの動作の前提となる環境の準備を行ってください。 前提製品および関連製品のインストールとセットアップについては、それぞれのマニュアル を参照してください。

- (1) 管理サーバに JP1/Base をインストールおよびセットアップしてください。
- 管理サーバに JP1/Network Node Manager i をインストールおよびセットアップしてく ださい。
- (3)「前提製品」を参照し、管理サーバに Java 実行環境をインストールしてください。
- (4) [オプション] 管理サーバに JP1/Integrated Management Manager をインストールおよびセットアップしてください。
- (5) [オプション] 管理クライアントに JP1/Integrated Management View をインストール およびセットアップしてください。

管理対象のセットアップ (HA8000V シリーズ/RV3000 A1,A3の場合)

管理対象の機種が HA8000V シリーズ/RV3000 A1,A3 の場合は以下の手順で、セットアッ プを行ってください。なお、SNMP トラップの設定については、iLO Web インターフェースで 行います。iLO Web インターフェースの操作方法については、HA8000V シリーズ/RV3000 A1 は「*iLO ユーザーガイド*」を参照してください。RV3000 A3 は「RV3000 A3 ユーザーズガ イド」を参照してください。

(1) iLO Web インターフェースを使用して、JP1 イベント通知ツール用のユーザーを登録し てください。

ログイン名は最少1文字から最大39文字の範囲で入力・設定してください。 パスワードは最少8文字から最大39文字の範囲で入力・設定してください。 ログイン名は以下の範囲の印字可能なASCII文字列を指定してください。

1) 英大文字 (A ~ Z) 2) 英小文字 (a ~ z)

3)10 進数の数字(0 ~ 9) 4) 「-」(ハイフン), 「.」(ドット), 「_」(アンダースコア)

- パスワードは以下の範囲の印字可能な ASCII 文字列を指定してください。
 - 1) 英大文字 (A ~ Z) 2) 英小文字 (a ~ z)
 - 3)10 進数の数字(0 ~ 9) 4)記号(「"」「%」「!」「¥」を除く)

管 理 対 象 の セットアップ (RV3000 A2 の場合)

管理対象の機種が RV3000 A2 の場合は以下の手順で、セットアップを行ってください。各 操作は、RMC CLI で行います。RMC CLI の操作方法については「RV3000 A2 ユーザーズ ガイド」を参照してください。

 RMC CLI に administrator ユーザーでログインして、次のコマンドで JP1 イベント通知ツ ール用のユーザーを登録してください。

なお、JP1 イベント通知ツール用のユーザーのパスワードには、「"」「%」「!」「¥」を使用 できません。 ユーザーのロールには、Administrator, Operator, ReadOnly のどれかを付与してください。

add user name=<ユーザー名> role=<ユーザーのロール>

設定例:

add user name=userA role= Administrator

(2) 次のコマンドを入力します。

set snmp forward_address=<管理サーバの IP アドレス>

設定例:

set snmp forward_address=192.168.0.1

(3) 次のコマンドを入力して RMC を再起動します。

reboot rmc

- ・ 送信されるトラップは SNMP v1 になります。SNMP v3 でのトラップ送信はできません。

システム環境変数の設定

JP1 イベント通知ツールが使用するシステム環境変数を設定してください。

システム環境変数を設定・削除した場合は、変更内容を反映させるために、管理サーバを 再起動してください。

SVEVTOOL_JAVA_OPTS システム環境変数は JP1 イベント通知ツール 01-04 以降で サポートします。

SVEVTOOL_JAVA_PATH

JP1 イベント通知ツールが使用する Java のパスを指定します。 SVEVTOOL_JAVA_PATH システム環境変数が未定義の場合、JP1 イベント通知ツールは PATH システム環境変数に設定されている Java を使用します。

PATHとSVEVTOOL_JAVA_PATHの両方が定義されている場合、JP1 イベント通知ツールはSVEVTOOL_JAVA_PATHシステム環境変数の設定値を優先して使用します。

システム環境変数の設定が正しく設定されていることの確認には svevcred -list コマンドを 実行し、認証情報一覧が表示されることを確認してください。svevcred コマンドの使用方法 については「svevcred コマンド」を参照してください。

変数値:

Java 実行環境のインストール先の java.exe が格納されているフォルダのパスを指定してください。

設定例1: Oracle Java Runtime Environment(JRE) 8 (1.8.0u261)の場合

C: ¥Program Files ¥Java¥jdk1.8.0_261¥bin

設定例2: Oracle Java Development Kit(JDK) 11 (11.0.12)の場合

C:¥Program Files¥Java¥jdk-11.0.12¥bin

設定例3:実行環境強化サポートオプション for Java の場合

C:¥Program Files¥Hitachi¥Cosminexus¥jdk¥bin

※ 設定例はインストール先がデフォルトの場合の設定です。インストール先をデフォ ルトから変更した場合はインストール先に合わせて設定してください。

注意事項:

・管理サーバの Java 実行環境が次の条件のどちらかに該当する場合には SVEVTOOL_JAVA_PATH システム環境変数を必ず設定してください。

- (a) Java 実行環境に Oracle Java Development Kit(JDK) 11 または実行環境強化サポートオプション for Java 09-87 以降 (Java11)を使用する場合
- (b) 複数の Java がインストールされている環境で JP1 イベント通知ツールが使用する Java を明示的に指定する場合

Java 実行環境が Oracle Java の場合、 "C:¥Program Files¥Common Files¥Oracle¥Java¥javapath"を指定しないでください。このパスを指定すると JP1 イベント通知ツールが正常に動作できなくなることがあります。

備考:

SVEVTOOL_JAVA_PATHシステム環境変数は JP1 イベント通知ツール 01-12 以降でサポートします。 JP1 イベント通知ツール 01-11 以前では PATH システム環境変数に設定している Java 実行環境を使用します。

□ SVEVTOOL_OCCURRENCE_TIME

デフォルトでは、JP1イベントの属性HCSM_OCCURRENCE_TIME(発生日時)は、タイムゾー ンが UTC で表示されます。属性 HCSM_OCCURRENCE_TIME をローカルタイムで表示した い場合は、システム環境変数に以下の変数を追加してください。

変数値:

任意の値を設定します。 設定が有効かどうかは変数が定義されているかどうかで判別されます。

備考:

属性 HCSM_OCCURRENCE_TIME のローカルタイムでの表示は、JP1 イベント通知ツー ル 01-10 以降で使用できます。

JP1 イベント通知ツールのインス トール/セットアップ

以下の手順で、管理サーバに JP1 イベント通知ツール本体のインストールし、セットアップ を行ってください。管理対象の装置を追加する場合は、(3)を実施してください。

- (1) JP1 イベント通知ツールの ZIP ファイルを任意のディレクトリに展開してください。
- (2) <(1)で展開したディレクトリ>にアクセス権を設定してください。
 - (a) SYSTEM アカウントには、「フルコントロール」権限を与えてください。
 - (b) <(1)で展開したディレクトリ>以下にはパスワードが(難読化された状態で)記録され ますので、パスワードを参照されたくないユーザーへアクセス権を与えないでくださ い。
- (3) コマンドプロンプトを開き <(1)で展開したディレクトリ>¥svevcred コマンドを実行して、「管理対象のセットアップ(HA8000 シリーズ/RV3000 A1,A3 の場合)」-(1)または「管理対象のセットアップ(RV3000 A2 の場合)」-(1)で作成したアカウントの認証情報を登録してください。

svevcred コマンドの使用方法については、「svevcred コマンド」を参照してください。

JP1/Integrated Management の 設定(オプション)

以下の手順で、 JP1 イベント通知ツールのイベント拡張属性定義ファイルを、 JP1/Integrated Managementの環境にコピーしてください。

(1) JP1 イベント通知ツールのインストールディレクトリにあるイベント拡張属性定義ファイルを、JP1/Integrated Management の環境にコピーしてください。

 - ・「コマンド」に「"C:¥svevtool¥svevtool.bat" \$*」

注意事項

・ 以下のいずれかの環境に JP1 イベント通知ツールをインストール・セットアップした場合、管理対象から JP1/Network Node Manager i への1 件の SNMPトラップを契機に2 件の JP1 イベント(※1)が登録されることがあります。

(1)JP1/Integrated Management - Event Gateway for Network Node Manager i(以下、

JP1/IM - EG for NNMi)を使用している。

 (2)JP1/Network Node Manager i の「ライフサイクルの移行アクション」に JP1 イベント 通知ツール以外の JP1 イベントを発行するアクションが登録されている。
 (JP1/Base の jevsend コマンドの登録や JP1/Network Node Manager i の IM 連携簡 易化ツールの登録など)

(※1)SNMP トラップの JP1 イベントと JP1 イベント通知ツールが通知する JP1 イベント

通知される JP1 イベントを 1 件にする必要がある場合、以下の方法で対処してください。詳細な手順はそれぞれマニュアルを参照してください。

JP1/IM-EG for NNMi のフィルターの設定で、除外条件に以下の条件を設定してください。

(a)ソースノードが管理対象の iLO/RMC の IP アドレス かつ
 (b)発生元が SNMP トラップ

(2)の場合

JP1/Network Node Manager i の「ライフサイクルの移行アクション」の設定で、JP1 イベント通知ツールの管理対象の iLO/RMC の IP アドレスから送信される SNMPト ラップを契機に実行されるアクションから、JP1 イベント通知ツール以外の JP1 イベ ントを発行するアクションを削除してください。

Preamble

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

For a library, complete source code means all the source code for all modules it contains, plus any associated interface definition files, plus the scripts used to control compilation and installation of the library.

Activities other than copying, distribution and modification are not covered by this License; they are outside its scope. The act of running a program using the Library is not restricted, and output from such a program is covered only if its contents constitute a work based on the Library (independent of the use of the Library in a tool for writing it).
